The majority's holding allows a sentence that has been vacated as illegal and no longer exists to be used to enhance the punishment imposed upon a defendant for a subsequent criminal offense. This holding is not supported by the text of the statute or any legislative history, conflicts with our prior case law, and most importantly is unjust.
